1. General description

The 74LV05A is a hex inverter with open-drain outputs. The outputs are open-drain and can be connected to other open-drain outputs to implement active-LOW wired-OR or active-HIGH wired-AND functions.

Inputs are overvoltage tolerant. This feature allows the use of these devices as translators in mixed voltage environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This device is fully specified for partial power down applications using I_{OFF} . The I_{OFF} circuitry disables the output, preventing the potentially damaging backflow current through the device when it is powered down.

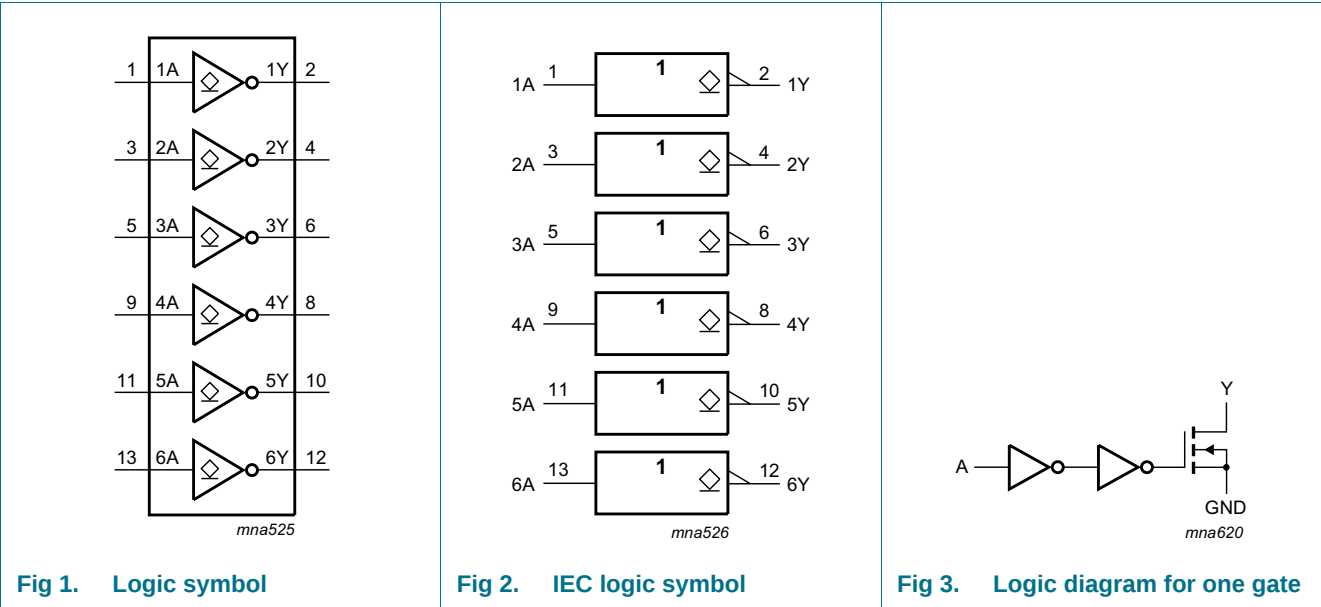

- Latch-up performance exceeds 250 mA per JESD 78 Class II

 - ◆ HBM ANSI/ESDA/JEDEC JS-001 Class 2 exceeds 3 kV
 - ◆ MM JESD22-A115-A exceeds 150 V
 - ◆ CDM JESD22-C101E exceeds 2 kV
- Specified from -40 °C to $+85$ °C and from -40 °C to $+125$ °C

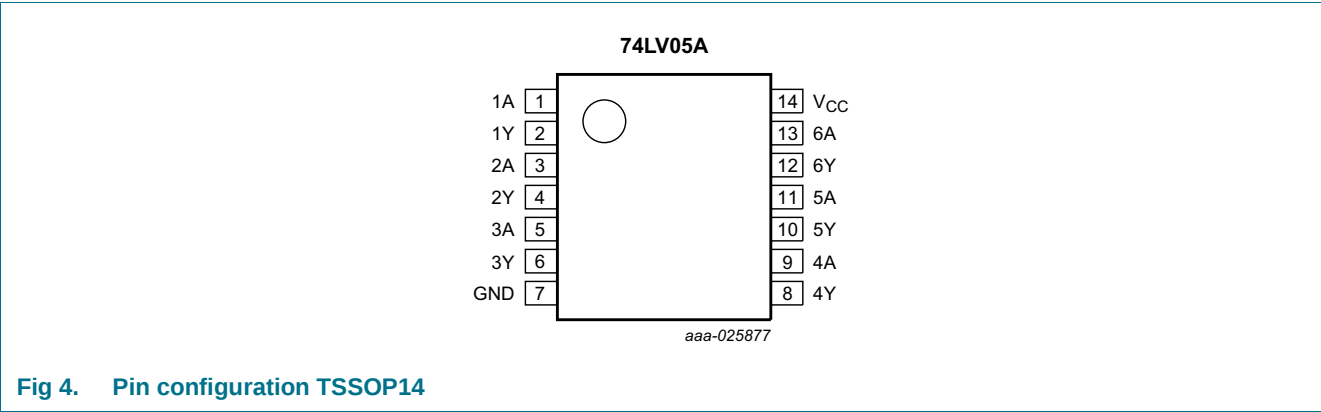

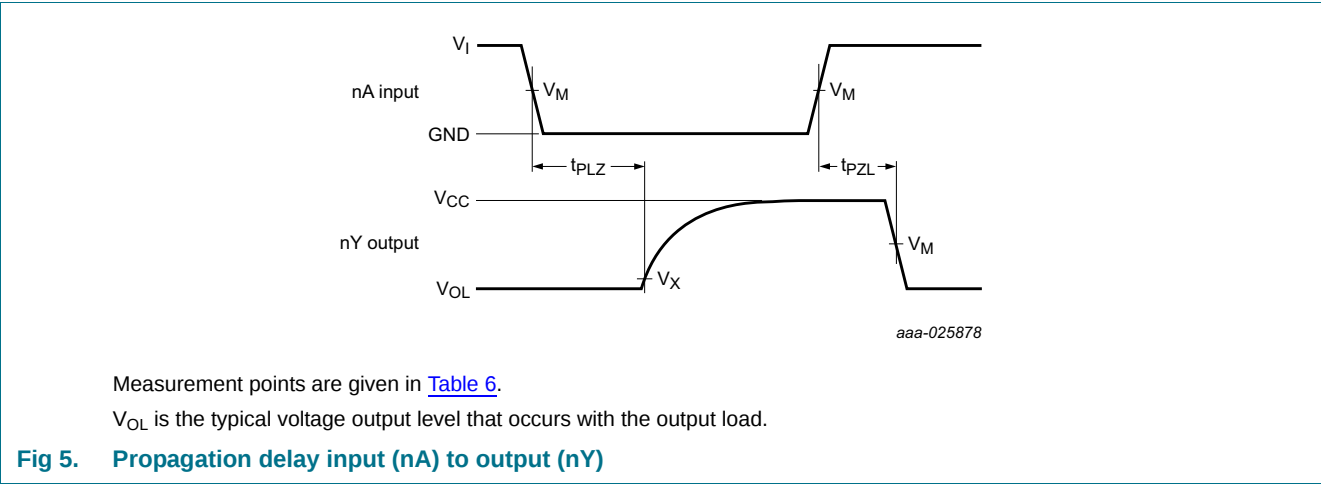

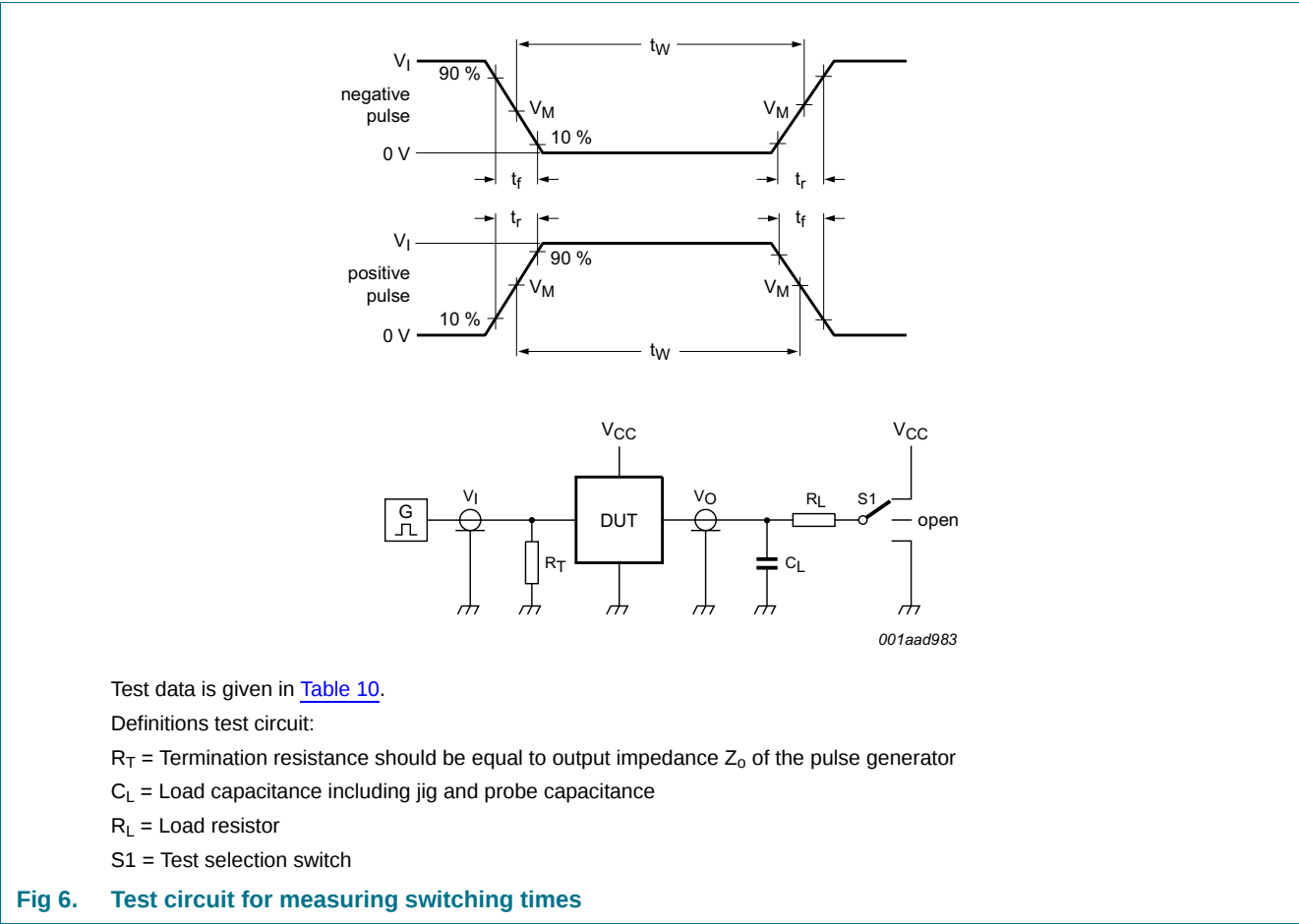

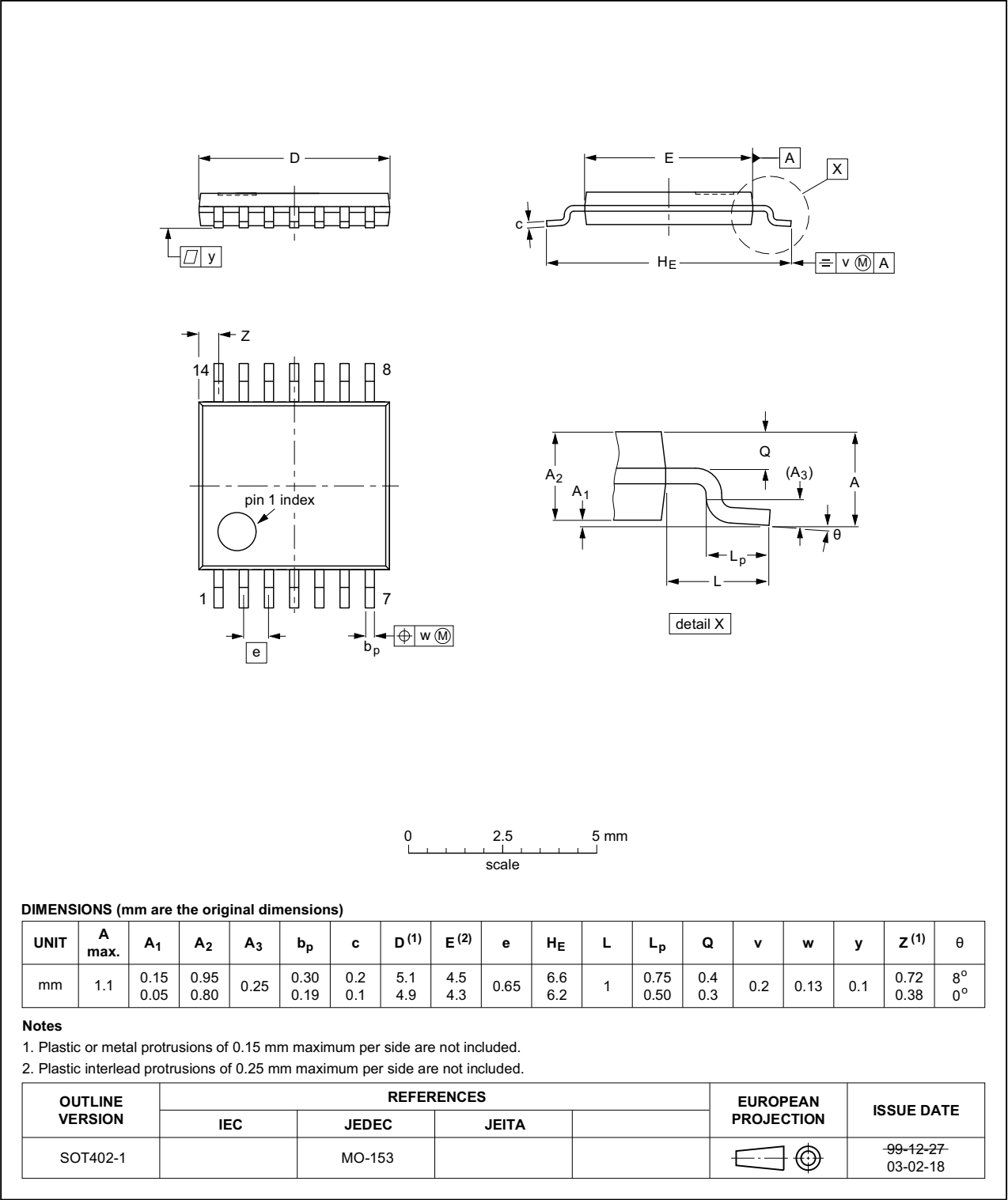


Fig 7. Package outline SOT402-1 (TSSOP14)
