The 74LV08-Q100 is a low-voltage Si-gate CMOS device that is pin and function compatible with 74HC08-Q100 and 74HCT08-Q100.

The 74LV08-Q100 provides a guad 2-input AND function.







Fig 7. Load circuit for switching times




