## 1. General description

The 74LVT244A; 74LVTH244A is an 8-bit buffer/line driver with 3-state outputs. The device can be used as two 4-bit buffers or one 8-bit buffer. The device features two output enables ( $1\bar{O}E$  and  $2\bar{O}E$ ), each controlling four of the 3-state outputs. A HIGH on  $n\bar{O}E$  causes the outputs to assume a high-impedance OFF-state. Bus hold data inputs eliminate the need for external pull-up resistors to define unused inputs

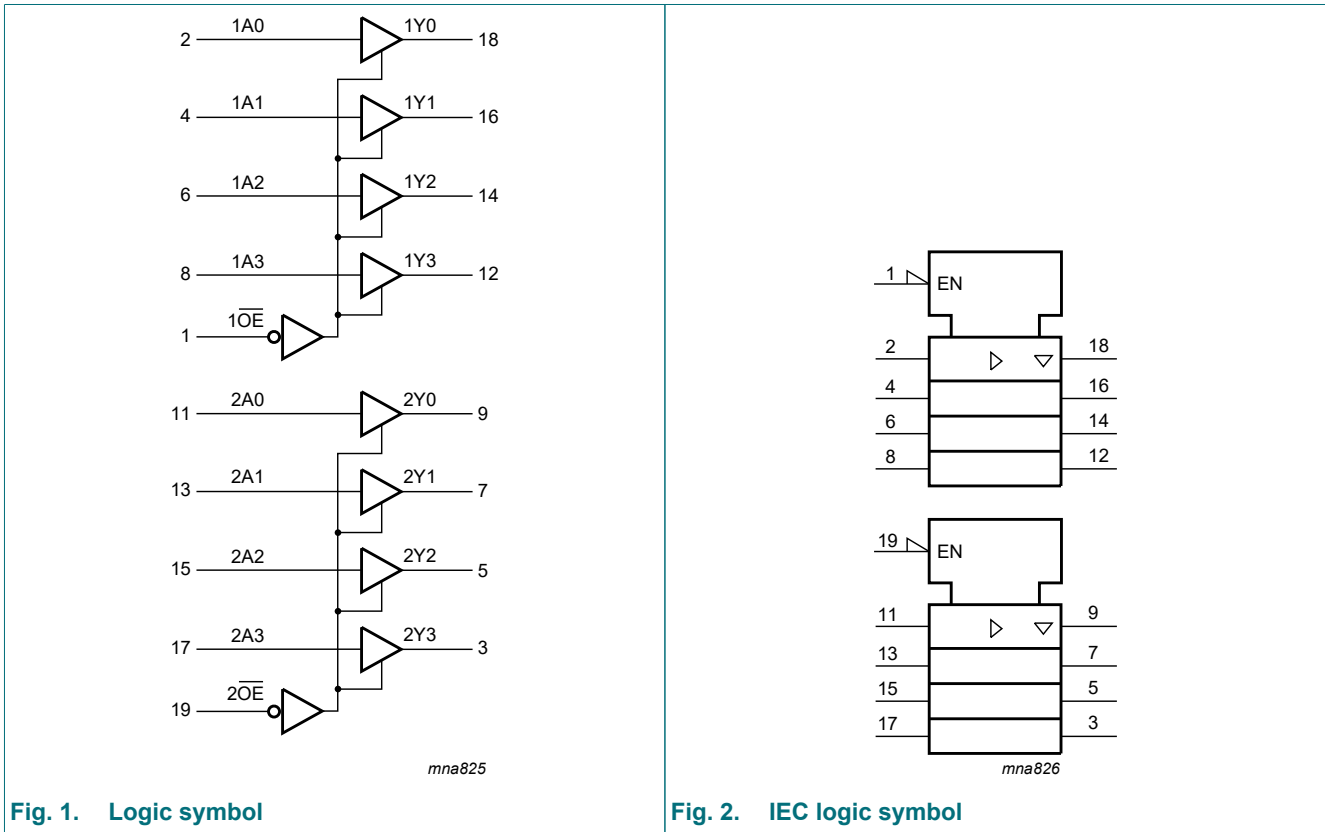
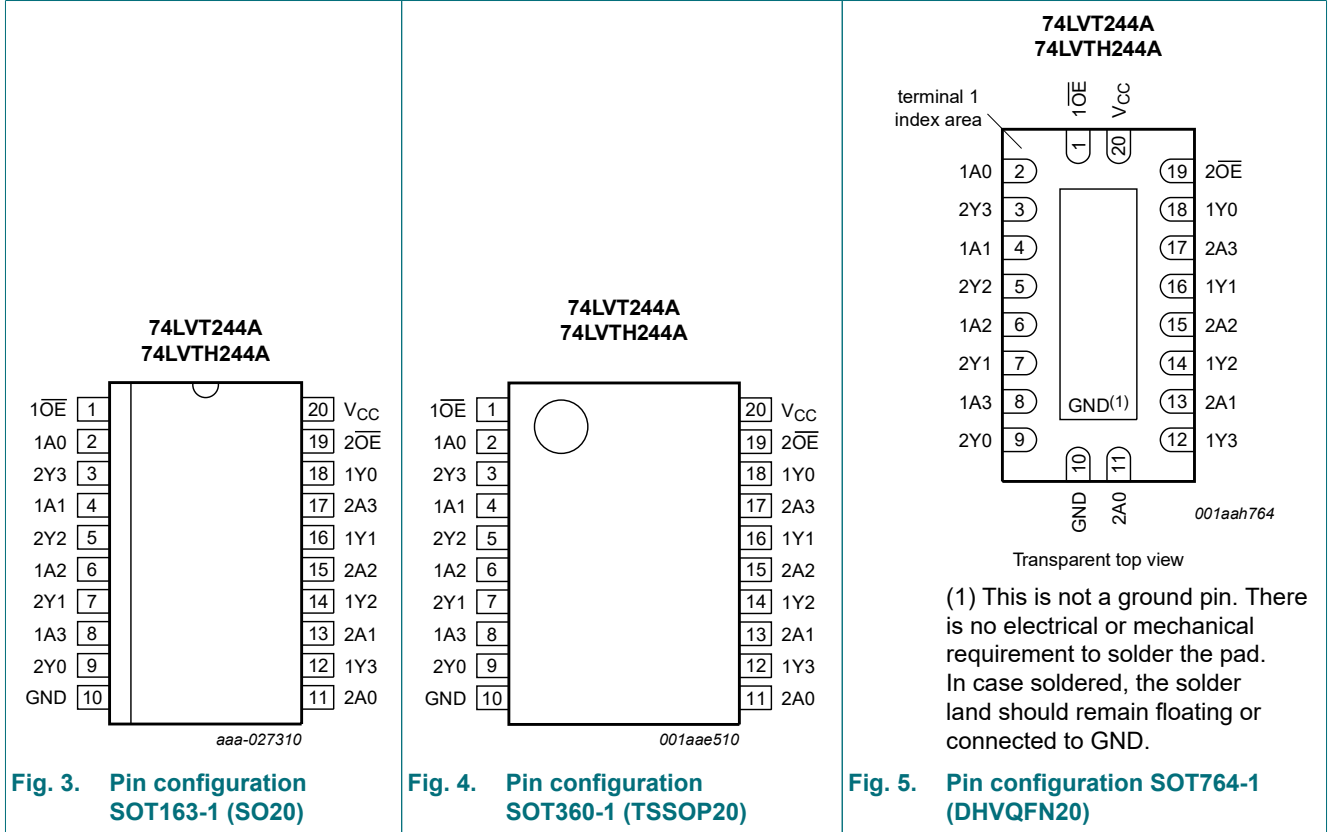


Fig. 1. Logic symbol

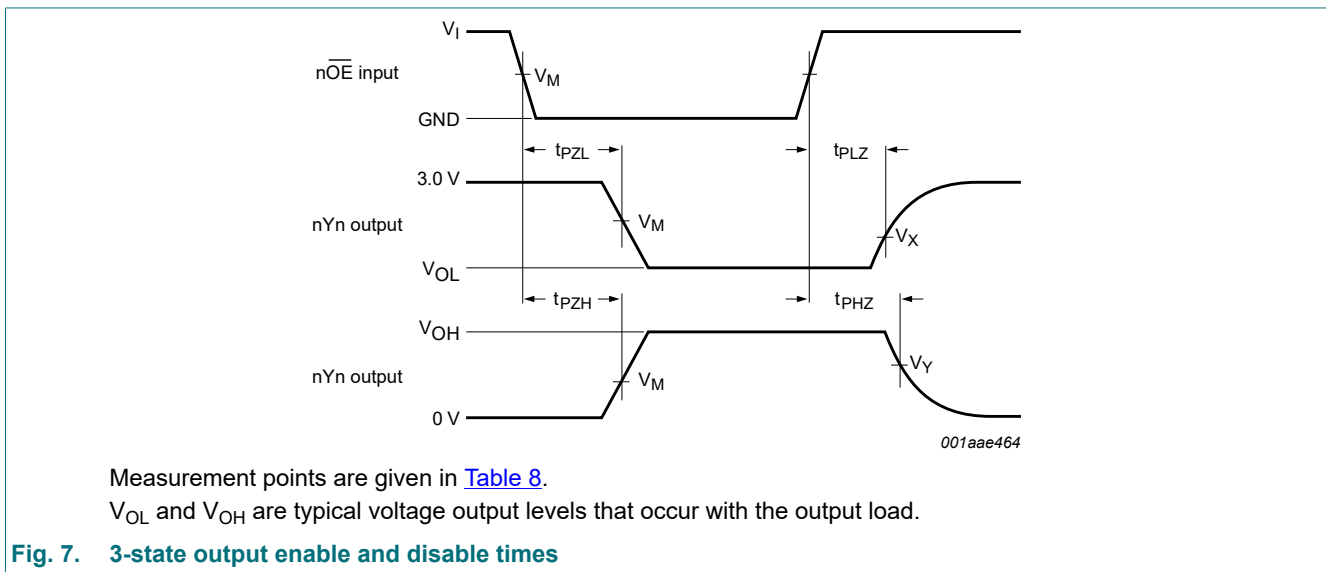
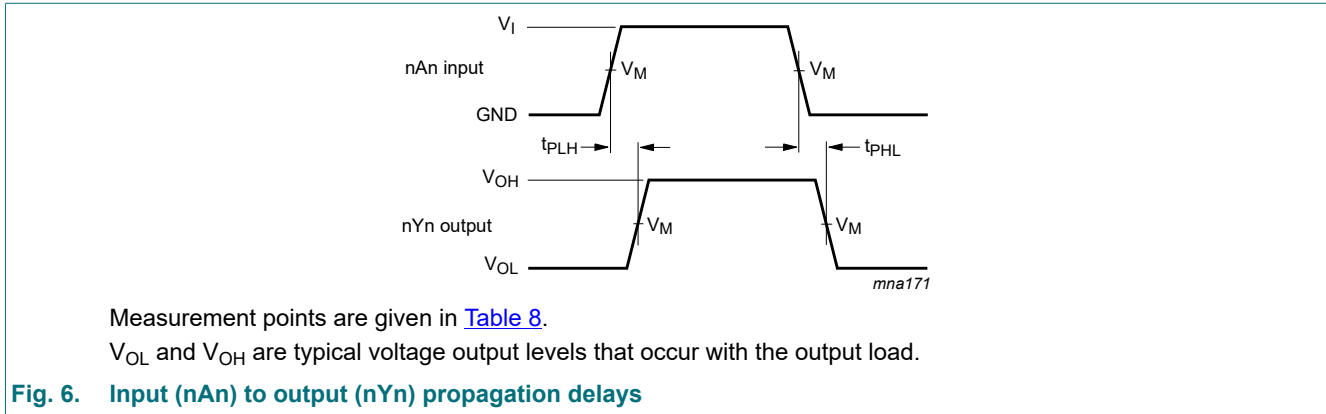
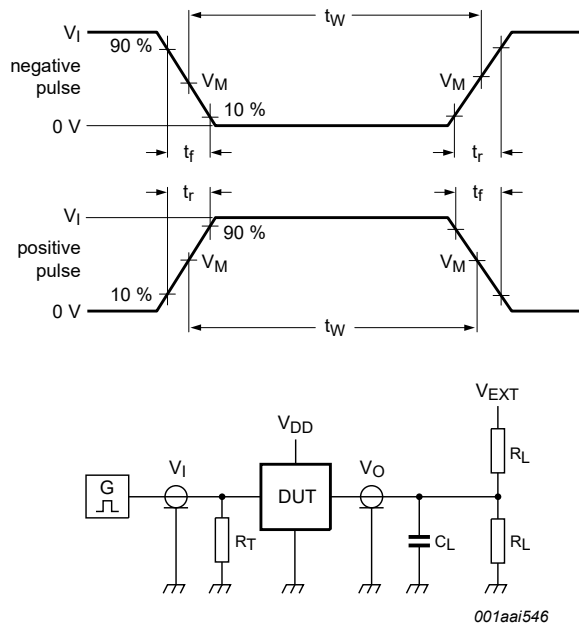

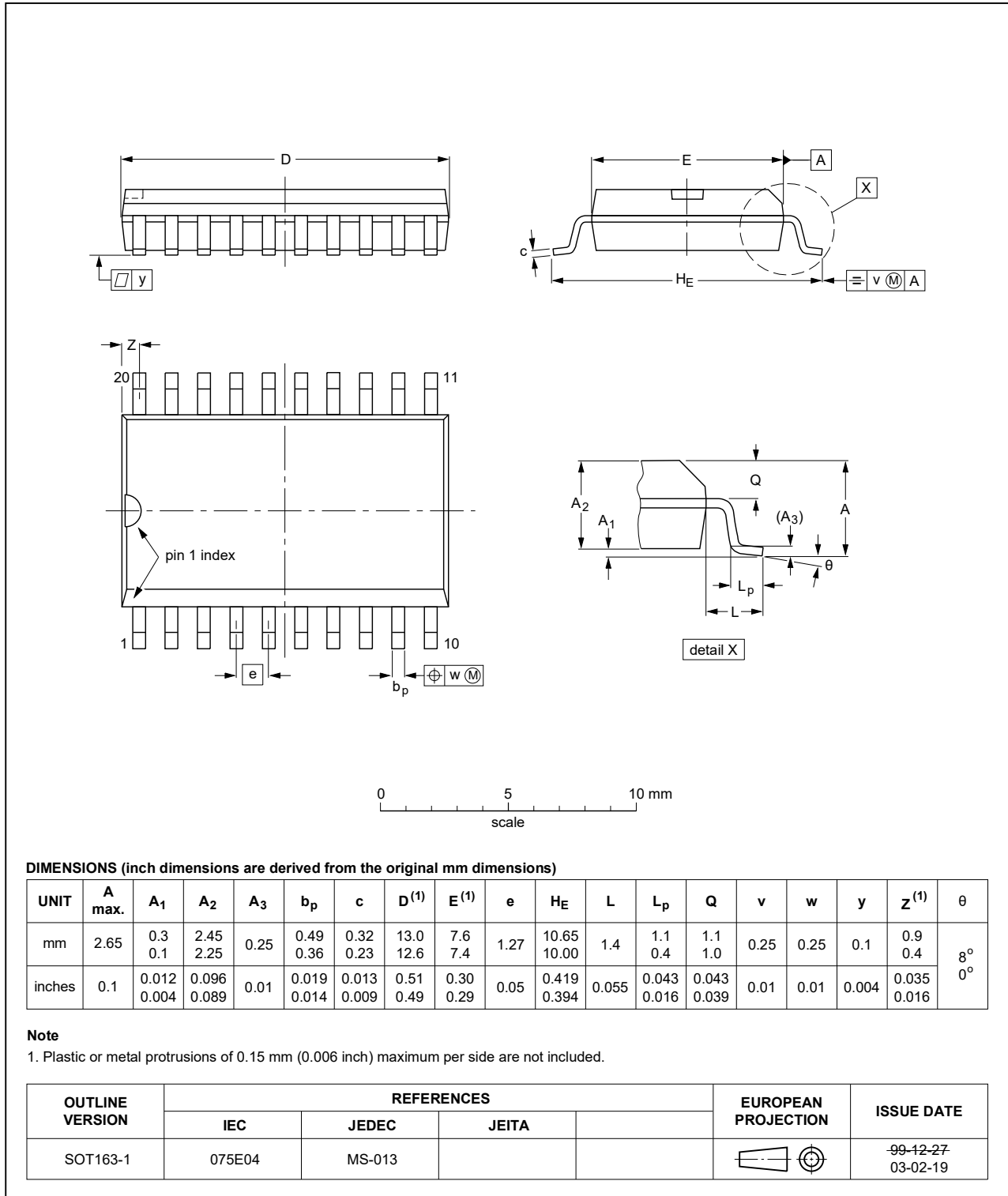


Fig. 9. Package outline SOT163-1 (SO20)

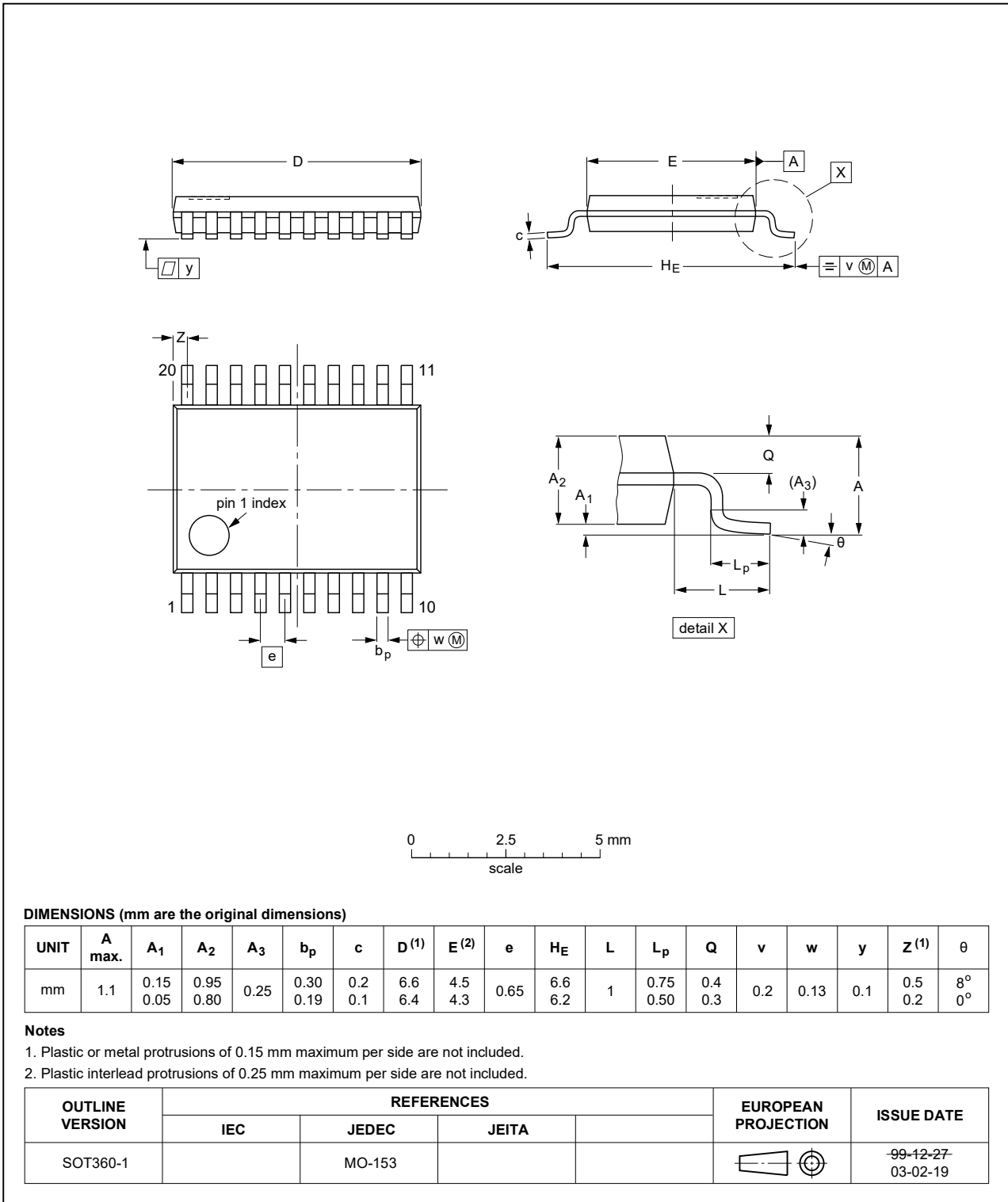


Fig. 10. Package outline SOT360-1 (TSSOP20)

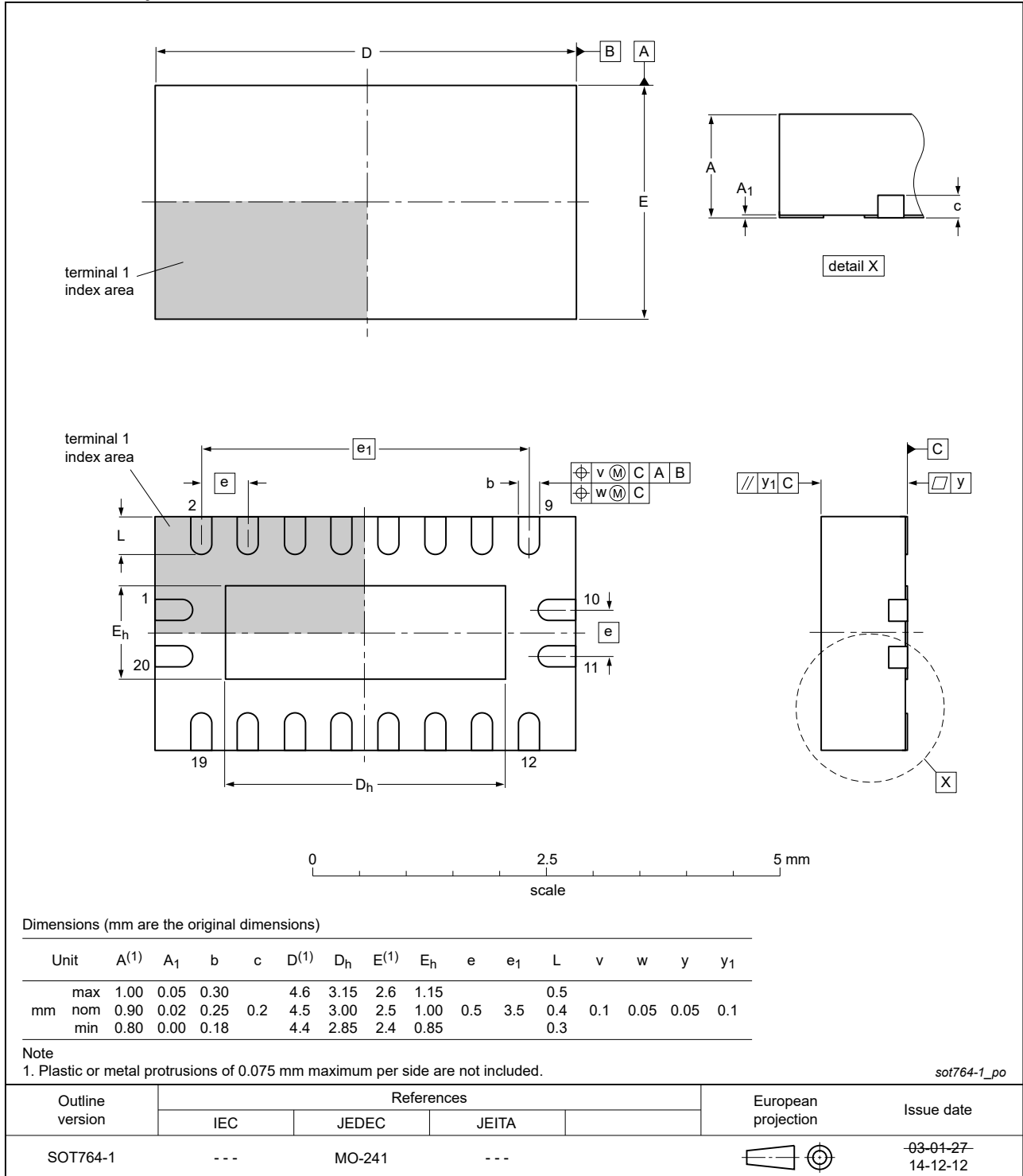


Fig. 11. Package outline SOT764-1 (DHVQFN20)
