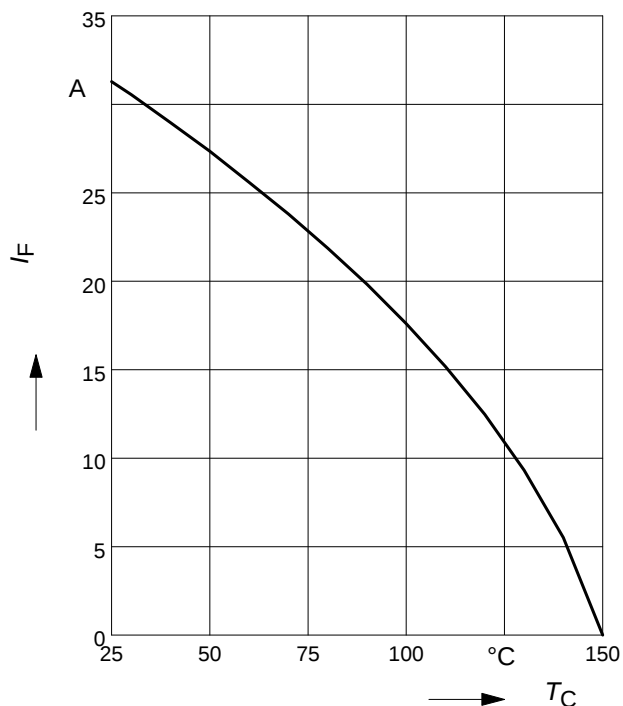

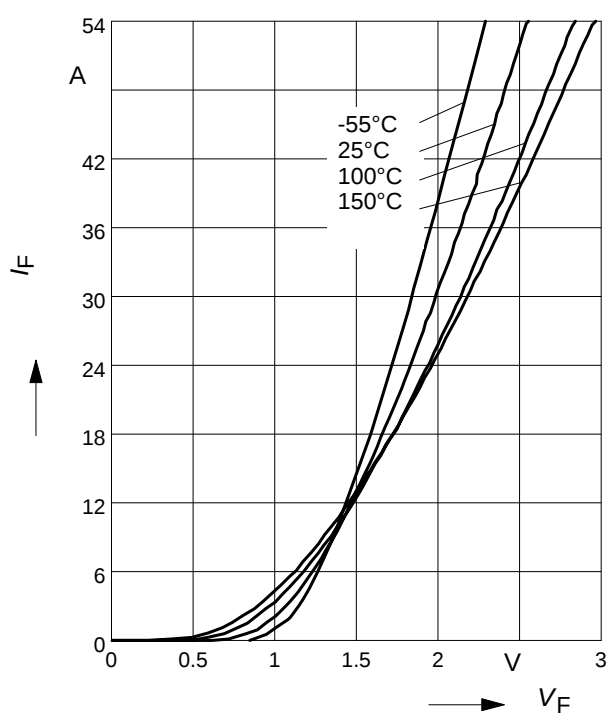

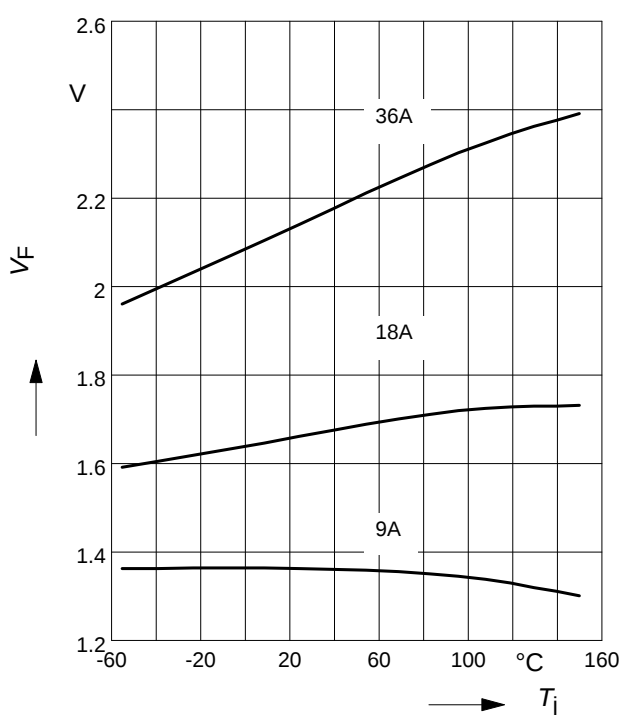
3 Typ. diode forward current

4 Typ. diode forward voltage

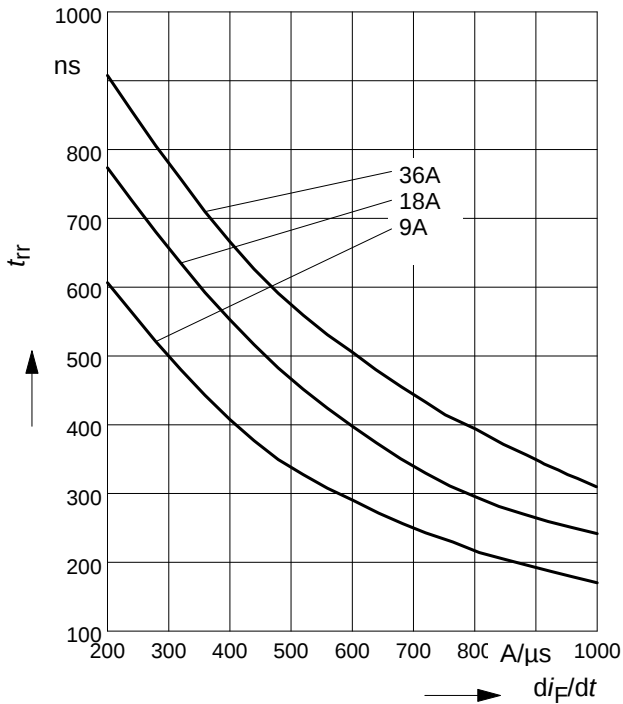

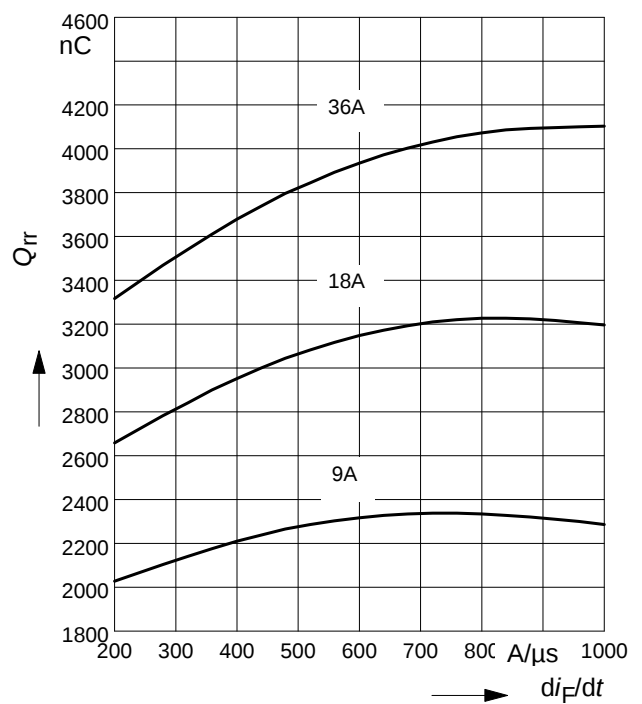

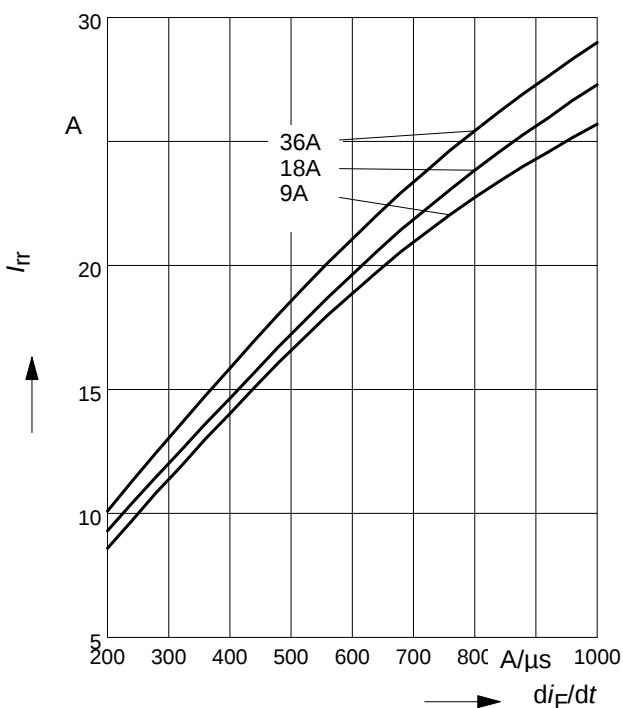

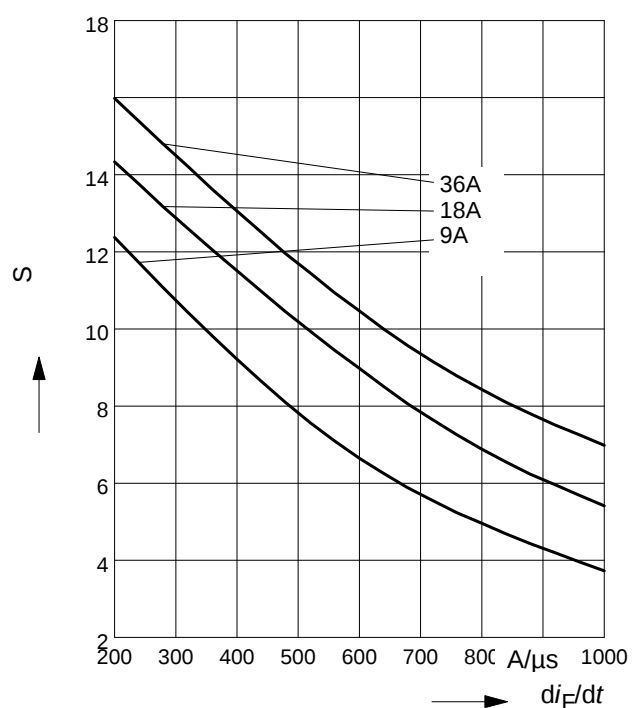

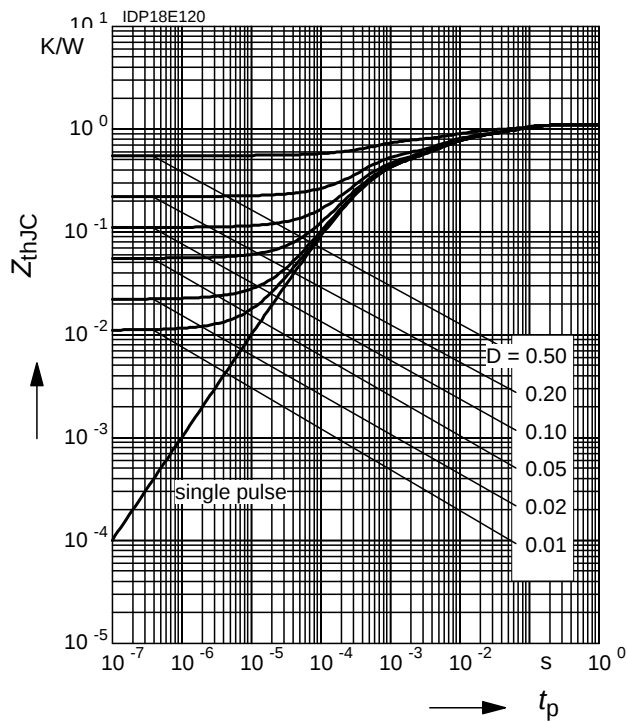

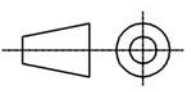
