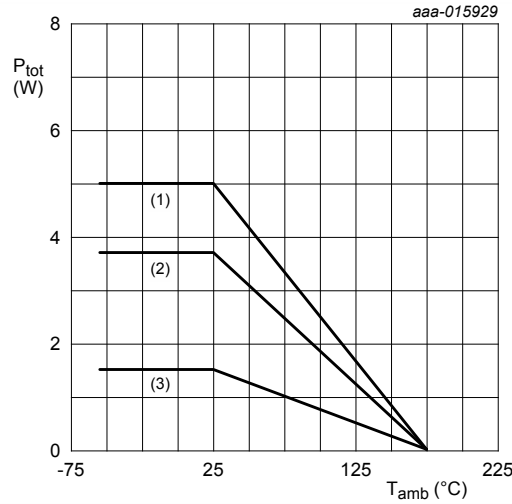

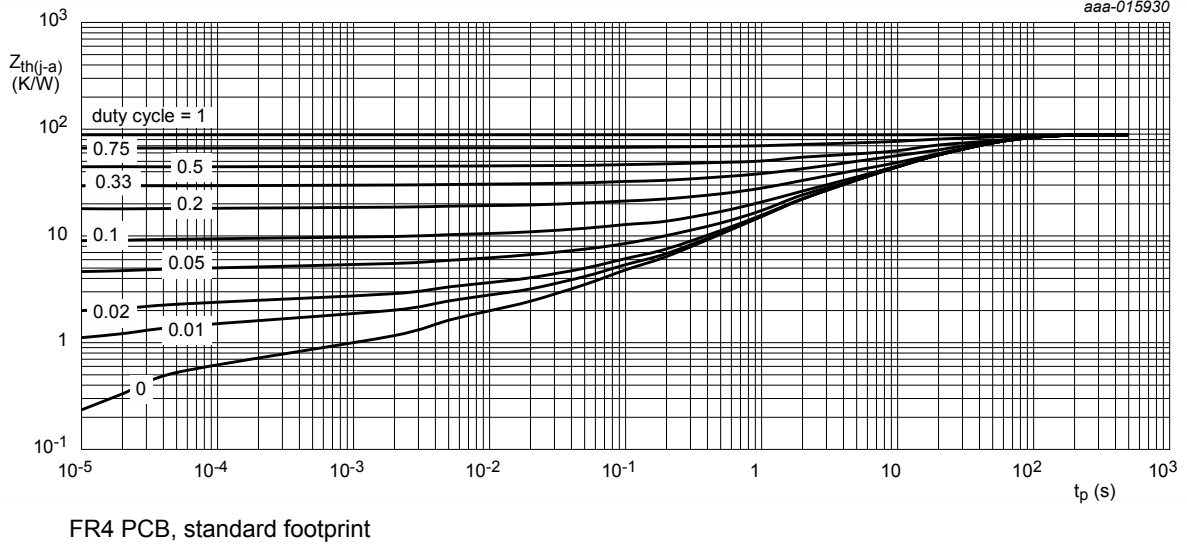
Fig. 1. Power derating curves

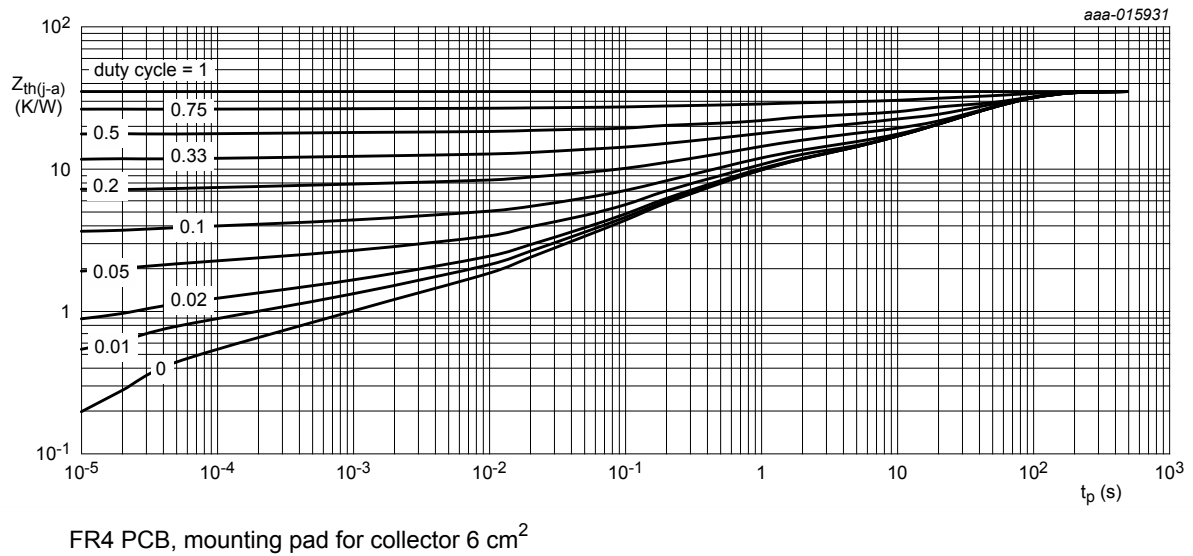

**Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values**



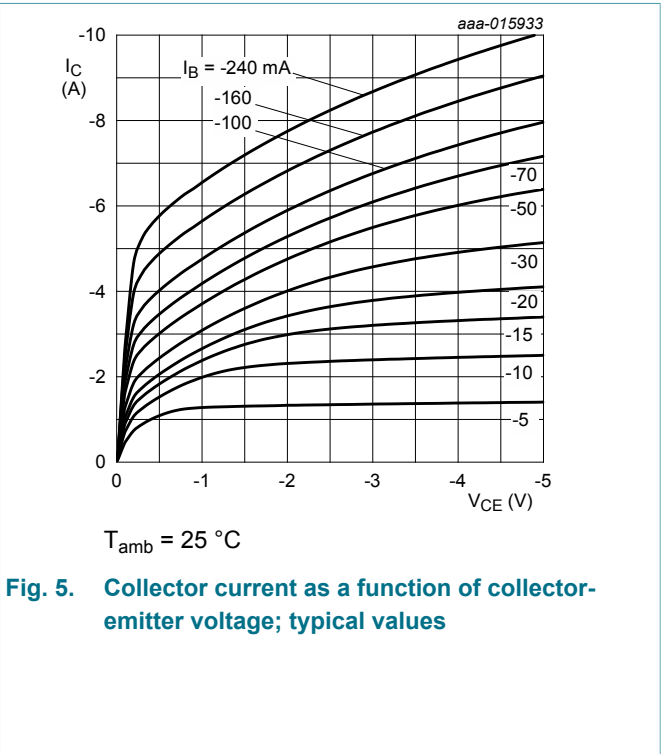
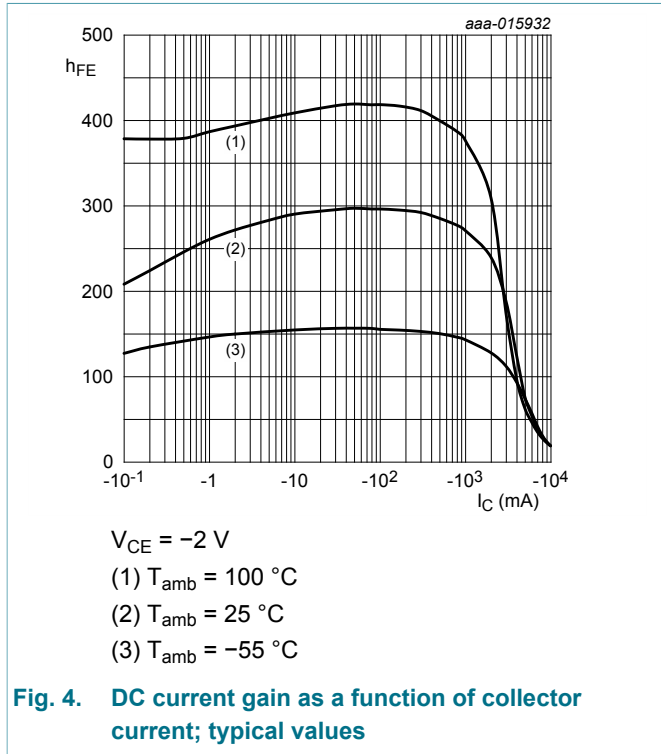
**Fig. 3. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values**

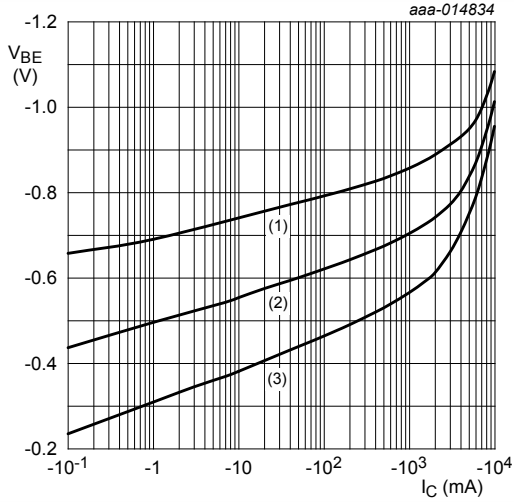

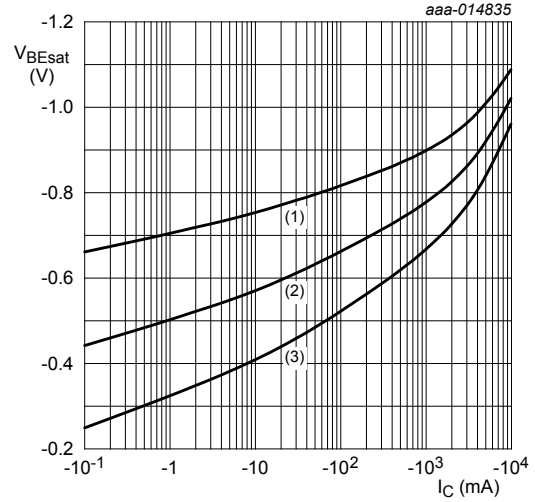

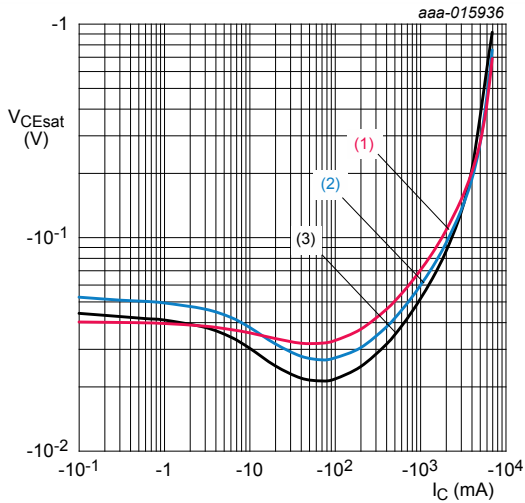

**Fig. 6. Base-emitter voltage as a function of collector current; typical values**



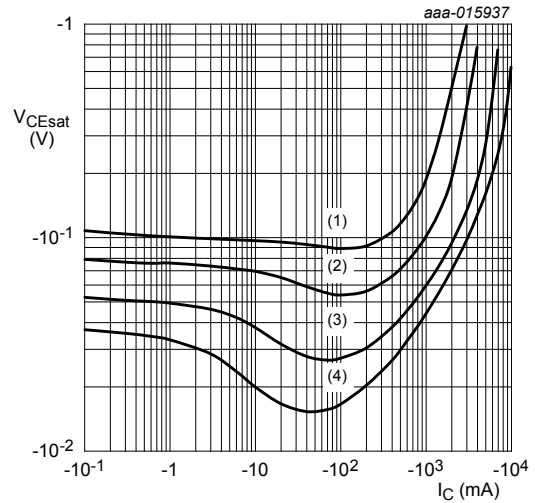

**Fig. 7. Base-emitter saturation voltage as a function of collector current; typical values**



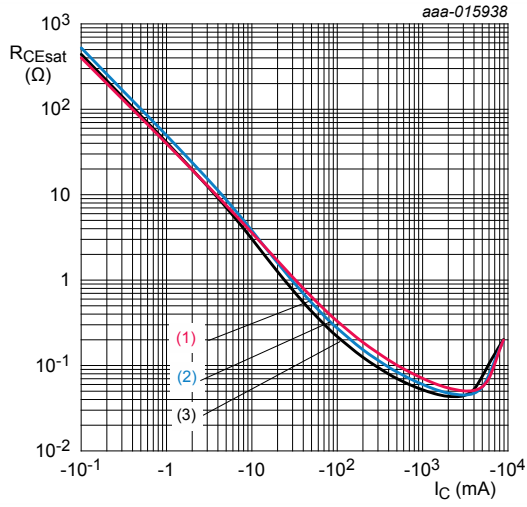

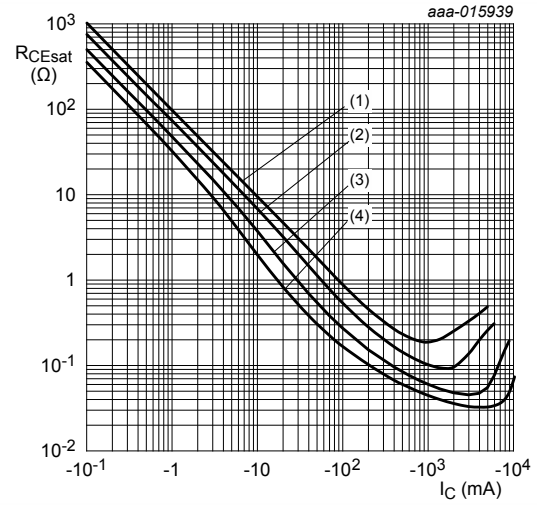
**Fig. 9. Collector-emitter saturation voltage as a function of collector current; typical values**

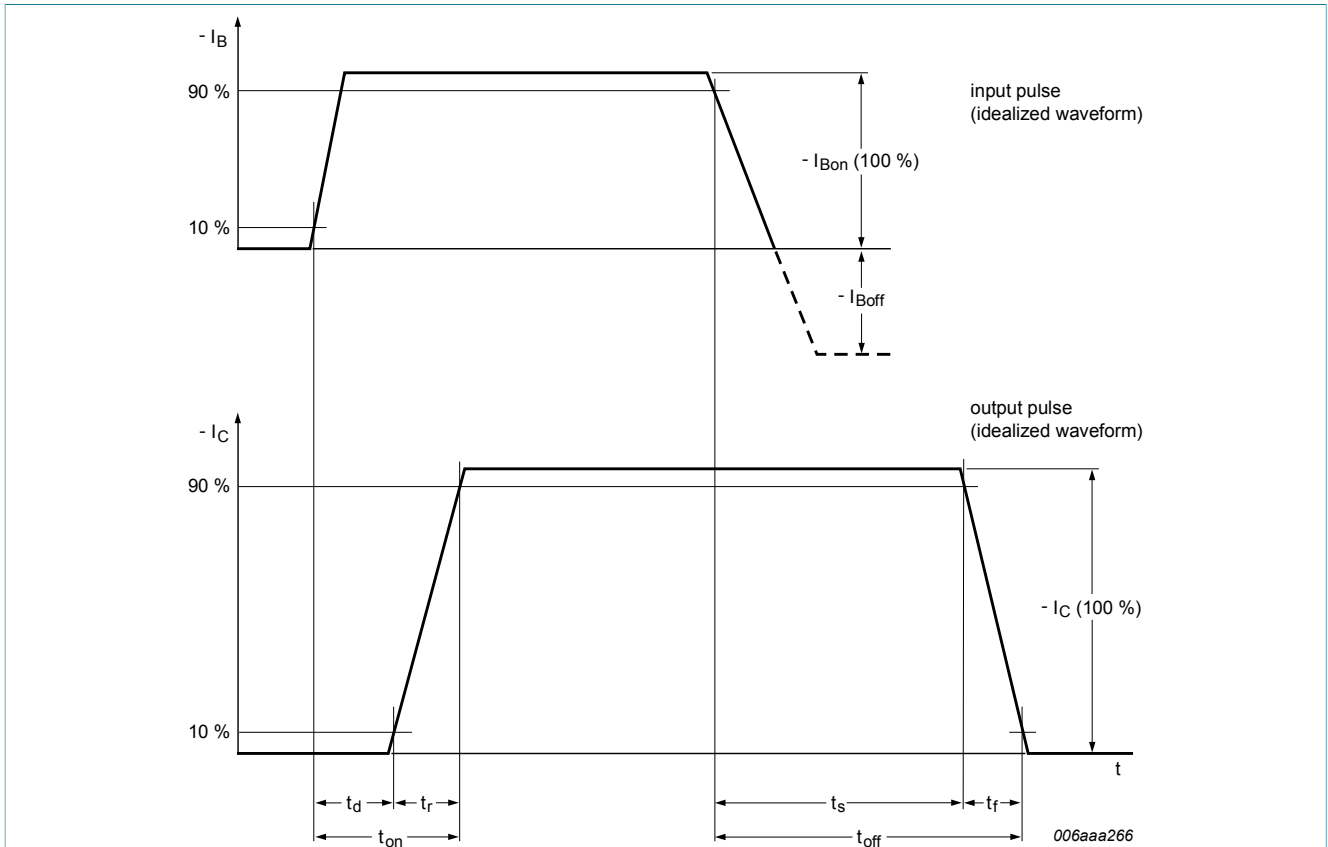


Fig. 12. BISS transistor switching time definition

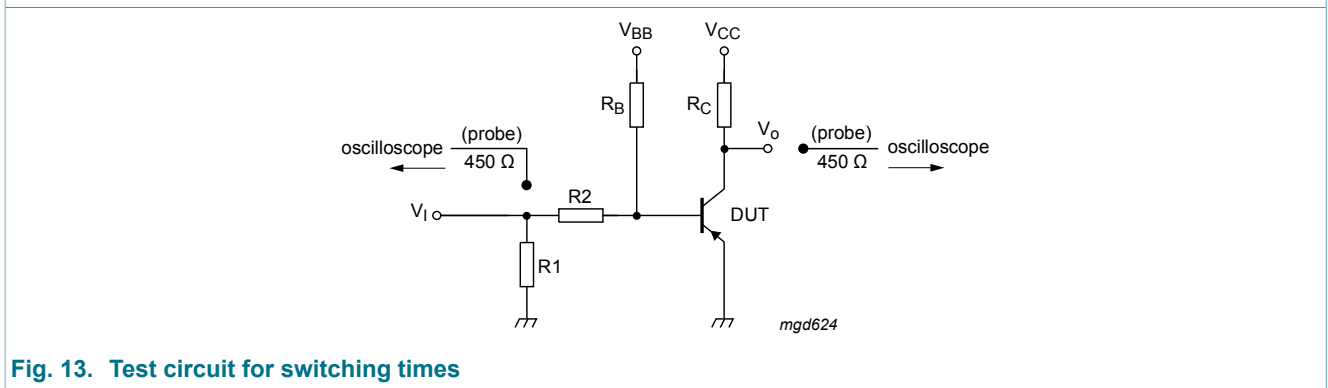


Fig. 13. Test circuit for switching times

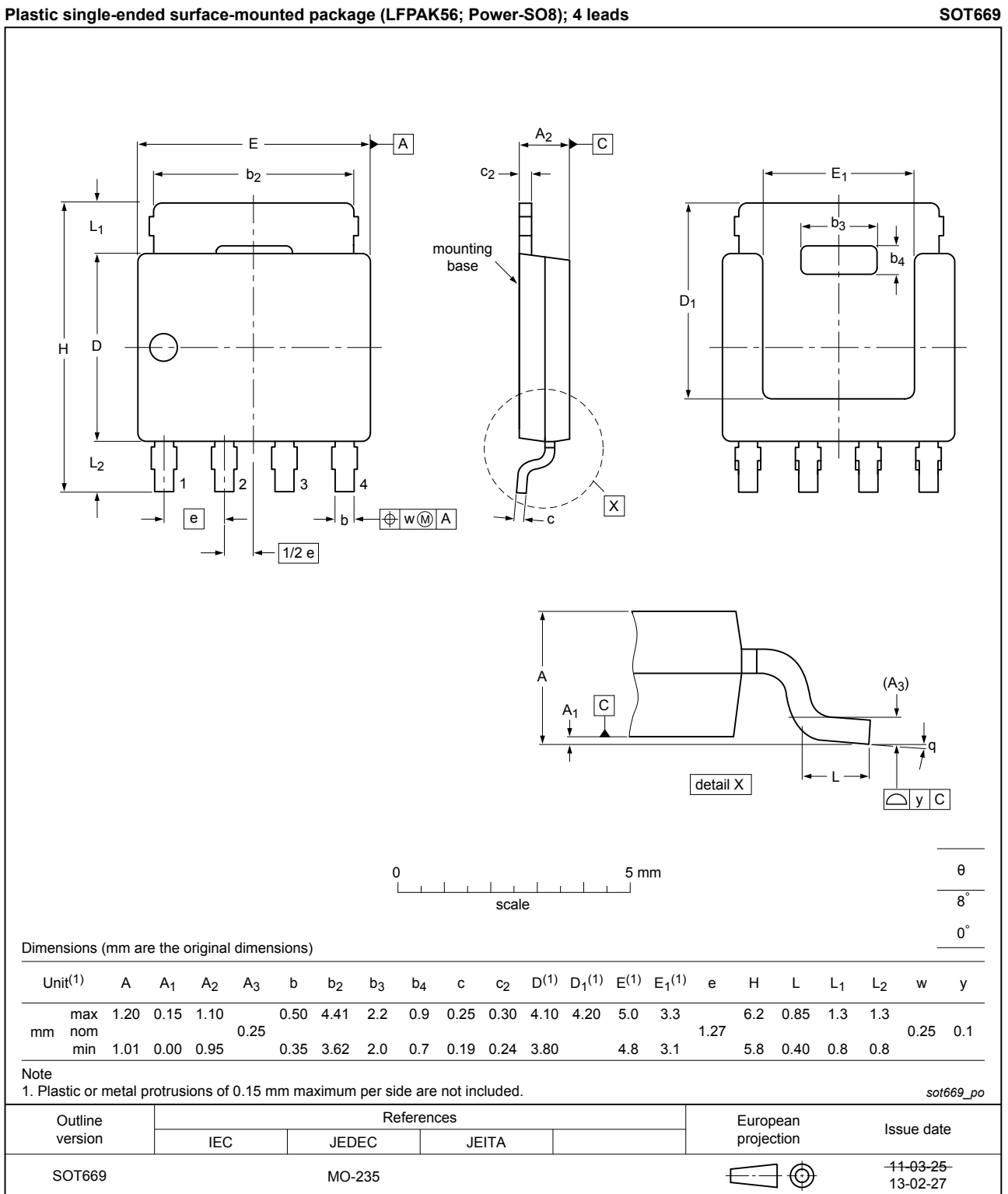


Fig. 14. Package outline LFAK56; Power-SO8 (SOT669)
