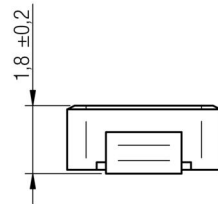

### F Typical Inductance vs. Current Characteristics



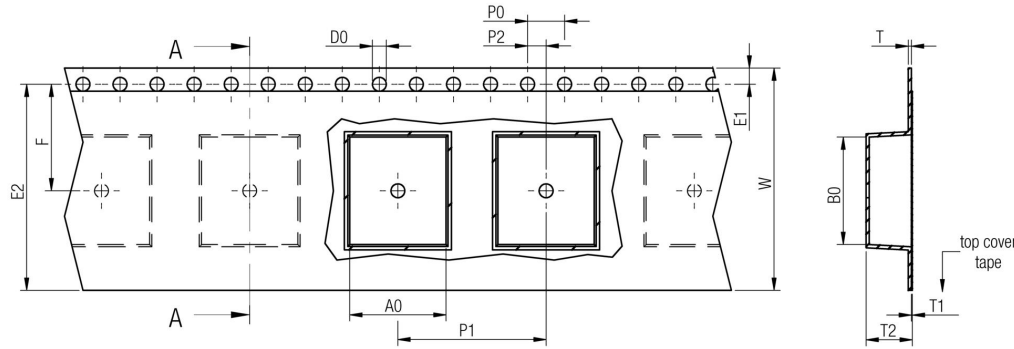
### F Typical Temperature rise vs. Current Characteristics



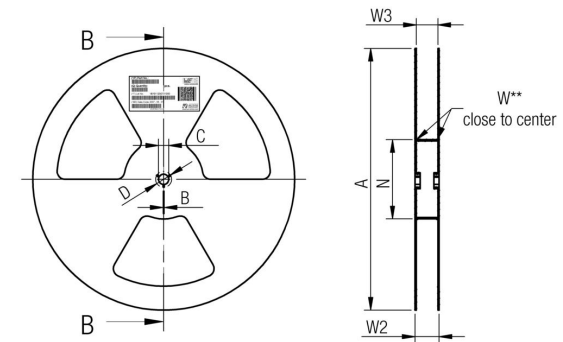
