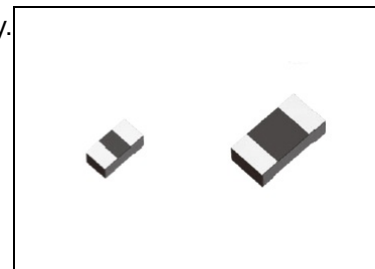

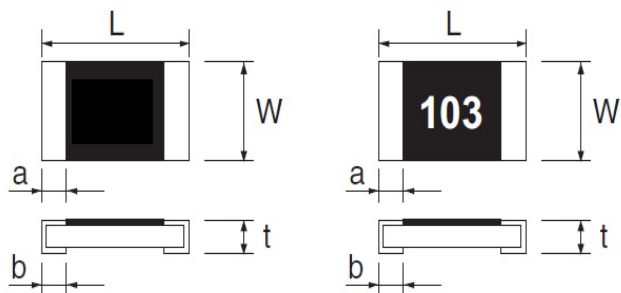

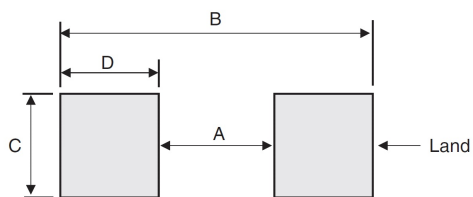

●Land pattern example



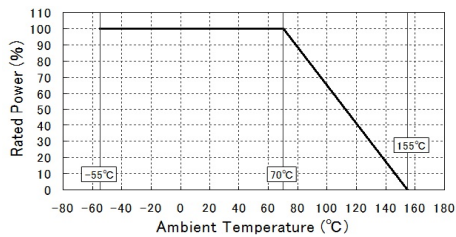

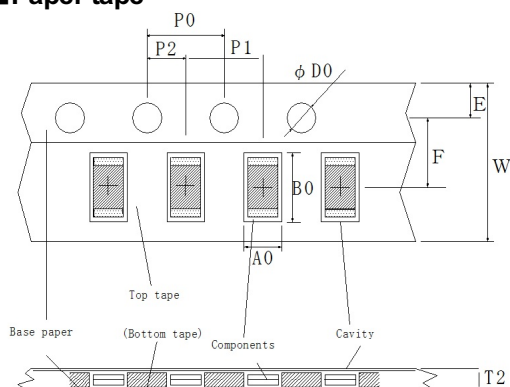

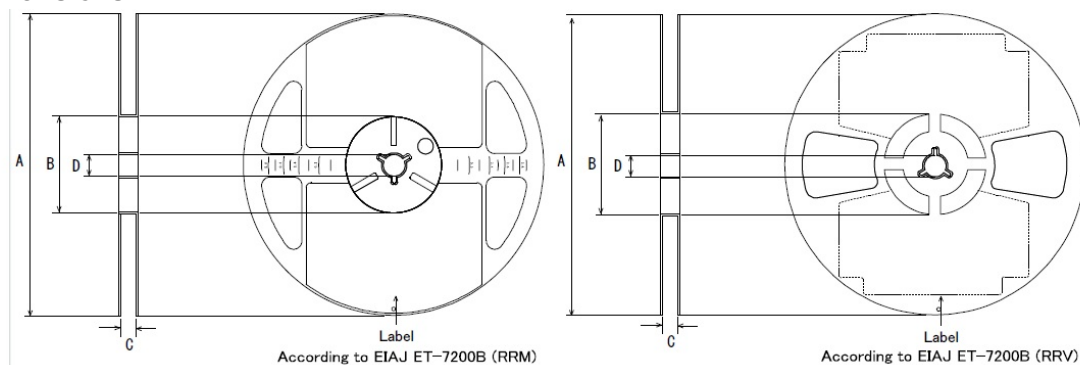
